**4. First Aid Measures**

<i>Inhalation:</i>	If dust is inhaled, remove from contaminated area. Encourage patient to blow nose to ensure clear passage of breathing. If irritation or discomfort persists, seek medical attention.

<i>Engineering controls</i>	<p>Local exhaust ventilation is required where solids are handled as powders or crystals; even when particulates are relatively large, a certain proportion will be powdered by mutual friction.</p> <p>Exhaust ventilation should be designed to prevent accumulation and re-circulation of particulates in the workplace.</p> <p>If in spite of local exhaust an adverse concentration of the substance in air could occur, respiratory protection should be considered.
